

We'd like to welcome you to the Peregian Beach Market.

Please complete the attached Stall Holder Application, scan and email it back to me at your convenience. You may also post it to the address at the top of the form or fax it back to the number listed although this option will take longer to process.

Please ensure you fully understand the terms and conditions that accompany the application.

\$20 million Public Liability Insurance is a requirement to trade at Peregian Beach Market (if you do not already hold PLI submit your application and wait for approval before obtaining it) and some companies that offer specific market insurance (but not limited to) are;

Traders Voice, AAMI, QBE and Market Stall Insurance. Some offer a 3, 6 or 12 month policy option and most can be obtained online.

Noosa Heads SLSC – Peregian Beach Market must be noted as an **'interested party' on your policy.**

Market sites are 3mx3m \$40, gazebo hire (we erect and dismantle) if required is \$25 each and tables (approx 1.9x.9m) are \$5 each.

Once you have completed your application and submitted it I will advise you of acceptance (or not) of your product or service by return email or text message.

You should always request a spot at the market by texting to 0428190055 after the completion of the market previous to the one you want to attend. We do not accept a booking request beyond the next scheduled market. I will always confirm (or not) to your text request and expect acknowledgement of it by return. Completion of the application will not automatically allocate a spot to you it just means that I have all the necessary documentation for any requests you make to attend in future.

Market is only held on the first (1st) and third (3rd) Sunday of any month.

Trading is from 7-12.30pm and ALL stall holders must be off site by 1.30pm.

Payment in cash is collected during the market usually between 9.30 - 11am and a receipt will always be issued.

So that you can enjoy and maximise your sales activities with us we'd like to make you aware of some aspects of our permit from Noosa Council that affect you.

On arrival at market... if you have been advised to drive in... it is not acceptable to queue onto the road or around the roundabout. It is a public road and is a fineable offence. Please park in front of the shops and wait for the line to dissipate then move into the queue along the front of the Surf Club. Be patient. This illegal practice of queuing on the road will adversely affect the market permit.

Parking anywhere at Peregian Beach is problematic given the parking times and consistent monitoring. Our visitors and shoppers to the market should have access to nearby parking and we urge you to be considerate of people who want to shop in the market and make it as easy for them as possible by not tusing those parking spots.

If you are fortunate enough to be allocated a car park behind your spot or within the market it should be considered a privilege not an expectation.

The best areas for all others to park after unloading is at the Recreation Area on Rufous Street (Off Woodland Drive, off David Low Way) where the area is free of parking inspection. A pedestrian lane runs from the recreation area to the roundabout at the top of Heron St just 50 meters from the market. If you decide to park in either of the carparks adjoining Kingfisher Park

you run the risk of a fine from Noosa Council and possible future denial of a spot with us for your lack of understanding.

Second hand items have some limitations. Unless you hold a Second-Hand Dealers Licence you will only be able to trade with us 4 times per year. Items purchased overseas are not included in the Act, nor are paper items such as books. Clothes, homewares and miscellaneous items all fall into the second-hand licence category.

Remember, we exist to support Lifesaving activities at Peregian Beach. The Life savers have priority accessing the Surf club and to and from the beach with equipment and personnel. They are all volunteers and deserve our respect and gratitude.

Permanent positions do not exist. Rather a spot is allocated as they become available and suit both the stall holder and the proposed site. Only at that time and in agreement with the stall holder it will be no longer necessary to request a position prior to each market. Stall holders should not get so attached to a spot or believe they cannot be moved if it is deemed appropriate by the market manager to do so. All care and consideration is given to each stall holder equally.

All rubbish generated at your site is to be removed from the grounds by you and not left in the public bins or alongside them when you depart the market.

Gazebo hire does not include walls. Any cable ties, string, tape or hooks used to merchandise your items must be removed from the hire gazebo before you depart.
